The Brazil Initiative focuses on advancing climate-resilience and the conservation of the Amazon and Cerrado biomes by supporting efforts to expand and guarantee Indigenous Peoples', Afro-Descendant Peoples', and local communities', including family farmers', land rights, security, and sustainable forest economies. We also focus on shifting financial systems and production, consumption, and trade to address the drivers of deforestation.

In addition, we support efforts to improve governance, policy, and accountability around land use; and to strengthen movements, narratives, and collective action in favor of forest, people, and climate. Gender equity, racial justice, and well-being are fundamental to our focus.

Supporting Indigenous Peoples', Afro-Descendant Peoples', and local communities' efforts to secure and exercise their land rights and tenure, manage their forests, and support their livelihoods.

Indigenous Peoples, Afro-Descendant Peoples, and local communities are long-term guardians of forests and biodiversity. By law, they hold the right to demand land titles for the lands they have historically occupied. Five hundred years of unsustainable natural resource extraction and land use, together with a lack of effective land titling led to violent conflicts over land between farmers, companies and the State - as Brazil still has millions of hectares of undesignated public lands and a long way to advance on Indigenous Peoples', Afro-Descendant Peoples' and local communities' land titling.

In addition to historical marginalization and unequal access to resources, Indigenous Peoples', Afro-Descendant Peoples' and local communities' decision-making power is also undermined by a lack of adequate policies and participation, including free, prior, and informed consent for activities affecting their territories. Different criminal networks operating in the region directly impact forest protection and Indigenous Peoples', Afro-Descendant Peoples' and local communities' territories.

The Climate and Land Use Alliance supports a range of organizations and movements to advance Indigenous Peoples', Afro-Descendant Peoples', and local communities' rights and livelihoods. This includes support for land titling, the development of sustainable forest economies and forest conservation, and increased access to finance.

Mapping and supporting Indigenous Peoples', Afro-Descendant Peoples', and local communities' territorial demands and using data and strategic communication tools to advance land titling.

Sustainable Forest Economies

Providing technical assistance and expanding access to credit, markets, and needed services for diversified and sustainable forest economies that value biodiversity, Indigenous Peoples', Afro-Descendant Peoples', and local communities' rights and people's wellbeing.

Strengthening Community Funds

Supporting territorial and community funds created by Indigenous Peoples, Afro-Descendant Peoples, and local communities to increase their access to funding. Supporting effective environmental and social governance and policies while strengthening

accountability to ensure equitable and

sustainable management of forest resources

and a just energy transition.

Sustainable management of public forests and of collective territories must be supported by policies that enhance forest economies, conservation, and communities' governance and well-being. Policies against structural racism, rights violations, and gender discrimination, particularly for access to land and finance, must be implemented. Land use for mining and agriculture must follow strong accountability processes.

The Climate and Land Use Alliance supports efforts to advance effective policies to prevent and address environmental crime, rights violations, deforestation and unsustainable land use. We also support work to secure good governance and greater transparency, safeguards, local participation, and oversight to ensure institutions are accountable to the commitments made at national and global levels to stop the drivers of deforestation. Impeding the social and environmental impacts of development models that threaten climate mitigation efforts are also a focus of our work.

Greater Forest Protection

Increasing the designation of new protected areas and collective territories while promoting rights and effective management.

Sustainable Land Use and Climate Policies

Increasing effective policies for sustainable land use and climate resilience.

Ending Environmental Crime and Rights Violations

Supporting effective policies and systems that increase local resilience against environmental crimes and rights violations.

Increased Accountability

Promoting increased transparency, robust safeguards, local participation, and oversight to keep institutions accountable to commitments and strong standards.

Strengthen Movements, **Narratives & Collective Action**

Supporting resilient, inclusive movements, narratives, and collective action on justice and rights, forest protection and regeneration, and climate resilience.

The opportunity for transformational change for Brazil's forests is high-and the stakes are even higher as the Amazon nears critical tipping climate points and land grabbing, rights violations, and violence continue.

Collective action in favour of securing land and other collective rights, the protection of biomes and climate resilience is crucial. Protagonism and advocacy by strong, resilient, and inclusive movements can strengthen narratives and build the public support and political will needed for change.

The Climate and Land Use Alliance supports the advocacy of Indigenous Peoples, Afro-Descendant Peoples, and local community organizations, shifting narratives in favour of justice, forests, and climate resilience; and broader movements in building collective action.

Both the Amazon and Cerrado are essential to stabilizing local and the global climates, storing carbon, securing freshwater, and regulating rainfall both nearby and far away. Agricultural production, as well as consumption and trade, must shift to ensure both biomes are conserved.

Deforestation, land conversion, and rights violations are also driven by poorly planned infrastructure and extractive industries, including the production of transition minerals, due to a lack of transparency and social oversight.

The Climate and Land Use Alliance supports efforts to remove deforestation and rights violations from supply chains, to enhance sustainable forest economies, and improve local food systems supporting livelihoods and well-being.

Increased Investment and Support for Sustainable Forest Economies

Promoting greater access to investment and technical support, guaranteeing business ecosystems that boost and consolidate sustainable forest economies that value biodiversity, rights, and human well-being.

Improved Food Systems

Supporting local and sustainable food systems grounded in thriving forest economies and low-emission agriculture, helping to fight illegal economies, gender inequality, and structural

High Integrity in Forest Carbon Markets

Ensuring forest carbon markets operate with high social and environmental integrity, particularly within Indigenous Peoples', Afro-Descendants', local communities' territories.

Advancing efforts to ensure the private sector adopts practices that are consistent with lowemission agriculture, biome conservation, thriving forest economies, and zero-tolerance of rights
